

**DISCLOSURE ON THE PURCHASE OF TREASURY SHARES
FROM 29 OCTOBER TO 2 NOVEMBER 2018**

Segrate, 5 November 2018 - Arnoldo Mondadori Editore S.p.A. (LEI Code 815600049A1F9AFE6666) announces the purchase on the MTA (Electronic Stock Market), in the period from 29 October to 2 November 2018, of no. 13,000 ordinary shares (equal to 0.005% of the share capital) at an average unit price of Euro 1.5272 for a total amount of Euro 19,853.35.

These transactions were made under the authorization to purchase treasury shares approved by the Shareholders' Meeting on 24 April 2018 (previously disclosed pursuant also to art. 144 bis of Consob Regulation 11971/99 and to art. 132 of Legislative Decree 58/98).
